## **Individual Members**

Any person above 18 years of age and residing in Singapore or Canada may apply to be an Individual Member.

## **Corporate Members**

Any Canadian or Singapore business or Company that is in any type of business having a registered office in Canada or Singapore may be eligible for corporate membership.

Corporate members are eligible to appoint 2 authorised representatives and entitled to 2 votes at Annual General Meetings.

## **PROCEDURE FOR APPLICATION AND TERMINATION**

- a) Every application for membership shall be made on the application form prescribed by SBC.
- b) The Board of Directors shall have the sole right and discretion to accept or reject any application without having to give any reasons for its decision.
- c) Please mail completed application form to the Council with a cheque made payable to "SINGAPORE BUSINESS COUNCIL", for payment of the annual subscription fee.
- d) Membership of SBC shall cease if
  - a. A member serves written notice of resignation to the Council to take effect in 30 days from the date of receipt of such notice and acknowledged by the Council in writing.
  - b. Annual membership fee is not paid within 30 days from the date when it is due.

## **MEMBERSHIP FEE**

- (b) Subscription fees are payable in advance, and no refund will be made to any members resigning or whose membership has been terminated.
- (c) A member whose membership has lapsed may be eligible for re-admission to the membership of SBC subject to the approval of the Board of Directors and the payment of a re-instatement fee of \$20.
